Building Blocks for a Brighter Future Family Seminar Promises Education and Fun

Don't miss out on ACB-Ohio's popular family seminar, "Building Blocks for a Brighter Future," to be held at the Ohio State School for the Blind in Columbus on September 29, 2012.

The seminar is packed with information and activities for families with children who are blind or visually impaired, as well as teachers of visually impaired students. The goals of this seminar are to give parents tools to work with; to encourage children to explore creative outlets through various activities; provide round-table discussion groups for parents and/or grandparents; and for families and siblings to network with one another.

The seminar is a great opportunity to learn about:

- The "alphabet soup" of special education, such as IEP and IDEA.
- Working with school administrators;
- How to support a teacher who is an advocate for your child;
- The latest technology and what is best for your child;

Our keynote speaker will be Colleen Miller, former state coordinator for the Ohio Coalition for the Education of Children with Disabilities. Mary Jo O'Neill, founder and director of Creating an Equal Playing Field, will facilitate the event and educate families on how to advocate for your child.

There will be panel discussions, resource materials, and technology experts offering hands-on technology demonstrations. Children will enjoy a day of games and activities, while parents share and learn. Lunch will be provided.

The fee is just \$10 per family, which includes lunch and a day of learning and sharing. Pre-registration is required by September 24.

There are also limited stipends available for VI teachers and families that drive long distances and need help with fuel costs.

Sign-in and exhibits open at 9:30 a.m. The program begins at 10 a.m. and ends at 3 p.m.

2012 Constitution and Bylaws Amendments

Four amendments to the ACB-O constitution and four bylaws amendments will be proposed at the ACB-Ohio annual meeting on Saturday, October 27, 2012. The amendments follow:

Constitution article 4.6. - Simply add an additional phrase at the end of the article starting: "To be eligible to run for the position of an officer on the ACB-O board, one must be a member of ACB-O for at least six months prior to the election."

Four amendments are to the standing committees bylaw article 4.0.

(Amendment 1) Original form:

4.3. CONSTITUTION AND BYLAWS COMMITTEE: The constitution and bylaws committee shall consist of at least three persons.

Proposed amendment:

4.3. CONSTITUTION AND BYLAWS COMMITTEE: The constitution and bylaws committee shall consist of a chair and at least two other members.

4.3.1 The committee prepares all proposed amendments to the constitution and the bylaws to then be submitted to the ACB-O annual meeting for a vote.

4.3.2. Amendments may originate from either the committee or from the membership.

(Amendment 2) Original form:

4.6. CREDENTIALS COMMITTEE: There may be a committee of creden-

tials. The committee shall consist of the secretary, treasurer, and one other board member.

Proposed amendment:

4.6. CREDENTIALS COMMITTEE: There shall be a Credentials Committee consisting of the secretary, the treasurer, and one other board member appointed by the president. This committee shall rule on all disputes of membership and voting eligibility of chapters and individuals as it relates to ACB-O.

(Amendment 3) Original form:

4.7. LEGISLATIVE COMMITTEE: The legislative committee shall consist of at least three members.

Proposed amendment:

4.7. LEGISLATIVE COMMITTEE: The legislative committee shall consist of at least three members.

4.7.1. The committee is responsible for keeping the ACB-O board and membership abreast of state and federal legislative issues of concern.

4.7.2. The committee shall promote and/or coordinate involvement of the board and membership with legislators and the public for greater understanding and appreciation of the needs and concerns of ACB-O members.

4.7.3. The committee shall coordinate ACB-O participation in the annual Washington, D.C. legislative conference.

(Amendment 4) Original form:

4.8. MEMBERSHIP COMMITTEE: The membership committee shall consist of a chairperson to be assisted by the rest of the board.

Proposed amendment:

4.8. MEMBERSHIP COMMITTEE: The membership committee shall consist of a chair and at least three others, including the ACB-O executive director.

4.8.1. The committee is responsible for developing and implementing programs to promote ACB-O membership.

4.8.2. The committee is responsible for keeping and maintaining a current and accurate electronic membership database to enable quick delivery of membership information in accessible formats to authorized persons. The executive director and ACB-O board members are authorized.

4.8.3. The committee is responsible for delivery of dues and membership information to the ACB national office on or before the deadline of March 15.

4.8.4. Release of lists of members' addresses, phone numbers, and e-mail addresses to individuals or organizations other than the board or executive director is prohibited. However, authorization may be granted to others by the Executive Committee or the board.

Meet Our Scholarship Winners — *By Vicky Prahin*

Two more excellent students, highlighted below, received ACB-Ohio scholarships last year..

Barbara “Barbie” Stahl, from Spring Valley, put her award to use during her final year of law school at the University of Dayton. She received her degree in May 2012, graduating summa cum laude. When she passes the Ohio bar, Barbie wants to work in a small firm, helping people plan their estates.

During her three years in law school, Barbie received about a dozen CALI awards, given to the student receiving the highest grade in the class. “I am both highly driven and goal oriented,” Barbie says. “I have an inexhaustible thirst for knowledge and an insatiable love of reading.” When asked how her blindness has affected her life, Barbie said, “I believe that blindness is in reality a special opportunity. It may present more life challenges, but it also gives a person the chance to take the more complex and interesting path through life. Rather than a hindrance, blindness is in fact a great adventure.”

Stacy (Boni) Border of Canton won the 2011 Linwood Walker Scholarship. She is working toward a degree in physical therapy, and all of her advisors and mentors speak highly of her motivation, her accomplishments, and her ability to give hope to patients. Initially, Stacy worked as a recreational therapist for several years after earning her Bachelor’s degree, but, she says, “Observing the improvements that patients were

making on a daily basis as a result of receiving physical therapy solidified my decision to return to school and achieve my goal of becoming a physical therapist.”

She has had to cut her work hours to a minimum in order to attend school full time and do all of the hands-on training necessary, so assistance from ACB-O has really helped.

At our upcoming state conference and convention, we will again award scholarships to outstanding students from around Ohio. Attendees can meet them during sessions on Saturday and after breakfast on Sunday.

ACB-Ohio is gearing up for the fall Community Shares employee campaign. I've been working with Ann and several board members in an effort to make families and VI teachers aware

of this important event. The Association for the Education and Rehabilitation of the Blind and Visually Impaired of Ohio posted a notice on their website homepage to invite VI teachers, and Ann was successful in getting our seminar posted in the VSA Ohio and Ohio Department of Education newsletters.

In scholarship endowment news, the University of Toledo and WSU are working with me toward growing our endowed scholarship funds. WSU recently sent a letter, under the signature of two Dayton area eye doctors, seeking financial support for our scholarship fund, and their effort is already producing contributions.

I've been working with UT regarding a similar letter to Toledo area eye doctors. Paul Rachow, a leader in the Frog Town Low Vision Support Group, has assisted me in acquiring a list of local eye doctors, which I have provided to UT. I'm hopeful that we'll be able to find a Toledo area doctor to sign a letter asking for donations to the fund.
