Around 85 registrants attended with 6 exhibitors and vendors. The event was filled with seminars, workshops, social events, exhibitors/vendors and speakers.

4b (Code: ) (Expenses \$ 8,239 including grants of \$ ) (Revenue \$ ) RECREATION : Activities are offered to provide physical and social opportunities otherwise not available to the blind and visually impaired. Two activities occurred : 1. The Winter Sports Retreat during Martin Luther King weekend in January 2020 at Punderson State Park in northern Ohio. Activities included skiing, snowshoeing, sledding and hiking outdoors plus indoor games, socializing, sing-alongs, and meals. Approximately 25-30 persons attended. . 2. The Summer Retreat took place during the first weekend in August 2020 on property owned by a family dedicated to assisting the blind and visually impaired. Activities included boating, jet skiing, swimming, fishing, hiking and picnicking. Approximately 12-15 persons attended.

4c (Code: ) (Expenses \$ 2,753 including grants of \$ ) (Revenue \$ ) LEGISLATION : The Executive Director and officers are charged with keeping up with current legislation effecting the blind and visually impaired at the national, state and local levels. This is done through subscription to newsletters and announcement lists provided by local and state government entities, contact with members of the state and national government, and subscription to the Leadership list which ACB provides. Once a year members visit Washington DC for a legislative seminar where they learn about vital issues regarding national legislative issues, and visit Congress to speak about those issues. Seven members represented ACBO in February 2020 and visited the offices of 15 Congresspersons.

Scholarships range from \$ 1,000 for a entering freshman to \$ 2,500 for a graduate student. Winners attend the Annual Convention to receive the awarded scholarship and receives a one year complementary membership to the organization. No scholarships were awarded in 2020.
