4a (Code:) (Expenses \$ 36,845 including grants of \$) (Revenue \$) CONFERENCE AND CONVENTION : Annual convention was held November 24, 2018 in Indianaopolis, Indiana at the Watefront Hotel. Approximately 100 persons attended with 29 exhibitors and vendors. The event was filled with seminars, workshops, social events, exhibitors/vendors and speakers.

4b (Code:) (Expenses \$ 10,710 including grants of \$) (Revenue \$) RECREATION : Activities are offered to provide physical and social opportunities otherwise not available to the blind and visually impaired. Two activities occurred : 1. The Winter Sports Retreat during Martin Luther King weekend in January 2018 at Punderson State Park in northern Ohio. Activities included skiing, snowshoeing, sledding and hiking outdoors plus indoor games, socializing, sing-alongs, and meals. Approximately 20-30 persons attended. 2. The Summer Retreat took place during the first weekend in August 2018 on property owned by a family dedicated to assisting the blind and visually impaired. Activities included boating, jet skiing, swimming, fishing, hiking and picnicking. Approximately 15-20 persons attended.

4c (Code:) (Expenses \$ 8,750 including grants of \$ 8,750) (Revenue \$) SCHOLARSHIPS : Six scholarships are available to students who are blind or visually impaired or plan to work in a field related to visual impairment or blindness. Scholarships range from \$ 1,000 for a entering freshman to \$ 2,500 for a graduate student. Winners attend the Annual Convention to receive the awarded scholarship and receives a one year complementary membership to the organization. Four scholarships were awarded in 2018.
